**Option #1:** Maxco shareholders that hold 1000 shares or more of Maxco Inc. stock will receive a distribution of 0.7362 share of Intergral Vision, Inc. (INVI) cusip #45811H106 stock for each share of Maxco stock owned.

Any fractional shares will be rounded up to beneficial owner level.
