#### 1. Objectives of This Chapter

The objectives of this chapter are to:

- Describe DTC's Reorg Deposits Mandatory Entitlements (RDMENT) function
- Provide templates for RDMENT data records

#### 2. Overview

DTC's RDMENT function allows Participants to receive information about their entitlement for Reorg deposits made on a specific day through the DAMP function. Each day, RDMENT generates a file that details stock and cash entitlements per deposit.

Eligible users who are DTC Participants can use the RDMENT function to receive information in machine-readable format.

#### 2.2 RDMENT Availability

RDMENT is generally available from 12:00 midnight to 4:00 p.m. Eastern Time.



#### 3. RDMENT Data Records

RDMENT data records are displayed in deposit CUSIP order. Data records consist of:

- 1. Header Record (positions 1 though 26); see page 3
- 2. Entitlement Detail Record (positions 26 through 214); see page 4

In the Entitlement Detail Record, positions 27 through 84 describe Participant deposit information:

DTC-assigned Participant number (positions 27 through 34)

Participant Reference Number entered by the Participant on DAMP (positions 35 through 49)

DAM Deposit ID, a unique number assigned to each deposit (positions 50 through 59)

DAM Deposit Date, the date of the actual deposit on DAM (positions 60 through 67

Envelope ID, which contains the deposited CUSIP number (positions 68 through 84

The remainder of the record is used for the entitlement information.

**Positions 68–84:** 17-character Envelope ID, uniquely identifying the initial mandatory exchange; consisting of:

- Envelope Check Digit Code (currently blank)
- Envelope Sequence Number

The Envelope ID, repeated for all line items describing the exchange for CUSIP deposited by the participant, is detailed in the following boxed fields:

- Entitlement CUSIP Check Digit (currently blank); position 112
- Entitlement Envelope Sequence Number (positions 113 through 114) If the line item reflects a dividend on the Entitlement New CUSIP, the Entitlement Function Code (positions 126 through 127) contains a valid value.
