The Depository Trust Company ("DTC") is filing this partial amendment ("Amendment") to SR-DTC-2017-004 ("Rule Filing"), which was filed with the Securities and Exchange Commission ("Commission") on April 6, 2017. The Rule Filing is proposing to adopt the Clearing Agency Liquidity Risk Management Framework ("Framework") of DTC and its affiliates, National Securities Clearing Corporation ("NSCC") and Fixed Income Clearing Corporation ("FICC," and together with DTC and NSCC, the "Clearing Agencies").

By this Amendment, the Clearing Agencies are proposing a technical revision to the Rule Filing to correct the table of contents in the Framework. The page showing these changes is redacted.
