Amendment No. 2 to SR-NSCC-2017-006

National Securities Clearing Corporation (“NSCC”) is filing this partial amendment (“Amendment No. 2”) to SR-NSCC-2017-006 (“Proposed Rule Change”), which was filed with the Securities and Exchange Commission (“Commission”) on April 7, 2017 and was previously amended on July 19, 2017 (“Amendment No. 1”). The Proposed Rule Change is proposing to adopt the Clearing Agency Stress Testing Framework (Market Risk) (“Framework”) of NSCC and its affiliates, The Depository Trust Company and Fixed Income Clearing Corporation.

By this Amendment No. 2, NSCC is proposing revisions to the Framework. The page showing these changes is redacted. NSCC shall file this pages separately with the Commission. Confidential treatment of this page is being requested pursuant to 17 CFR 240.24b-2.
