On April 6, 2017, The Depository Trust Company ("DTC") filed a proposed rule change filing (SR-DTC-2017-004) ("Rule Filing") with the Securities and Exchange Commission ("SEC") proposing to adopt the Clearing Agency Liquidity Risk Management Framework.
