Subject:	Development of Rapid Issuance (RI) Service – Timeline Update

## **Background**

As previously announced via Important Notice <u>B#19146-23</u>, the DTC Underwriting team is developing a Rapid Issuance (RI) service as part of the overall Underwriting Transformation initiative. RI will enable underwriters to bring shelf offerings to market quickly as the DTC eligibility process will be performed at the base CUSIP level. Rapid Issuance program creation and issuance draw down will be performed in Underwriting Central (UWC), the new underwriting application.

## **Timeline Update**

Go-live for the new Rapid Issuance eligibility process is scheduled for Q3 2025.

## **User Acceptance Testing (UAT)**

User acceptance testing will commence in Q1 2025; timelines and requirements will be communicated in subsequent Important Notices and through targeted outreach.

## **Industry Working Group**
