Subject:	MF Info Xchange Service Enhancements

Effective **September 27, 2024**, National Securities Clearing Corporation (NSCC) will implement **enhancements to MF Info Xchange** to assist clients in complying with regulatory requirements for **Money Market Reform.**

In July, 2023, the Securities and Exchange Commission ("SEC") adopted amendments to rules that govern money market mutual funds ("Money Market Reform") under the Investment Company Act of 1940. The amendments remove provisions in the current rule that permit a money market fund to suspend redemptions temporarily through a gate and allow money market funds to impose liquidity fees (Mandatory and Discretionary) under certain conditions.

In connection with the Money Market Reform, NSCC collaborated with working groups of the Investment Company Institute's Broker/Dealer Advisory Committee, and Bank/ Trust/Retirement Advisory Committee to consider recommendations for enhancing NSCC's Mutual Fund Services for the purpose of providing our clients with capabilities to assist in complying with the new regulatory requirements.

In order to standardize communication of Mandatory and Discretionary Liquidity fees, the following two new event types will be added to MF Info Xchange:

- Liquidity Fee Notification Discretionary Fee
- Liquidity Fee Notification Mandatory Fee

Clients wishing to utilize API capabilities to send and/or receive these Liquidity Fee notifications via MF Info Xchange APIs, will be able to view and download the API schema for these notifications in the DTCC API Marketplace ahead of these notifications' delivery date.

The API schemas will be available in the DTCC API Marketplace on June 28, 2024 (PSE Marketplace) and July 12, 2024 (Production Marketplace).

DTCC offers enhanced access to all important notices via a Web-based subscription service. The notification system leverages RSS Newsfeeds, providing significant benefits including real-time updates and customizable delivery. Data elements and field requirements are included in the attached Appendix. The Appendix is for informational purposes and may not represent the final data dictionary. NSCC reserves the right to make additional changes prior to implementation.

<u>Please note:</u> Details regarding enhancements to Fund/SERV in support of the aforementioned reform were communicated via <u>Important Notice a9441</u>. Enhancements to MFPS II Profile Security will be announced in a separate Important Notice.

<u>PLEASE NOTE:</u> In order to perform code migration, MF Info Xchange will <u>not</u> be available in production on September 26, 2024, between 8pm-10pm ET.

TESTING

Effective September 6, 2024, clients can begin testing in the Participant Services Environment (PSE).

Clients are strongly encouraged to test and must contact their Relationship Manager before testing begins if access to PSE has not been previously established.
